Letter to Cherwell District Council from HFDAG members

Dear Mr Colwell

I am writing on behalf of all the members of the Hanwell Fields Development Action Group, of which we have just over 60 in number. All oppose the local plan and in particular the planned areas of Ban2 & Ban5. Our complaint is the manner in which to respond to the local plan, we feel that the response is not presented in a easy way to express our opinions effectively. As such it comes across as though everyone should be planning experts, with a distinct knowledge of both policy and terminology. Unfortunately most respondents are not.

It has been expressed that a more simple approach is required and we are proposing that we either submit our concerns individually in a letter whereby the council then interprets this in to the correct terminology with the correct references or someone from the council attends a HFDAG meeting to note our individual concerns to then be formally documented as opposition to the plan. However we welcome to any suggestions you may have about how the process could be simplified.

On a cautionary note, If no such action takes place then I will advise all our members to complain individually to CDC, the council ombudsman, the planning inspector and the Secretary of State. Furthermore we will all proceed to make cases about the legality of the plan. We are also investigating if we have grounds to take legal action against CDC for a potential breach of contract based on the original requirements for the development of Hanwell Fields and the possibility of a breach of our Human Rights. We will fight this on

every level and on every point until the view of the Hanwell Fields Community has been listened to, which so far no-one has bothered to ask.
